Paris La Défense, June 14, 2011: The Vicat group (NYSE Euronext Paris: FR0000031775 – VCT) announces today that it has successfully closed and signed a €480 million 5-year revolving credit facility.

The Facility will be used for general corporate purposes including the refinancing of an existing €445 million multicurrency revolving credit facility dated 20th July, 2009, extending the average maturity of the Group's debt, which now stands at 5.5 years, and 6 years for Vicat S.A.

The Mandated Lead Arrangers and Bookrunners in this transaction were BNP Paribas, Crédit Agricole Corporate and Investment Bank, Crédit du Nord, Crédit Mutuel-CIC (Documentation Agent), HSBC France, Natixis (Facility Agent) and Société Générale Corporate & Investment Banking (the corporate and investment banking division of Société Générale).

The financing was agreed with a syndicate of 9 banks: BNP Paribas, Crédit Agricole Corporate and Investment Bank, Crédit du Nord, Crédit Industriel et Commercial, Crédit Industriel et Commercial - Lyonnaise de Banque, HSBC France, LCL, Natixis and Société Générale.
